2. The demand trends are representative because 21% of the 650 machine-builders with 100 and more employees in the 10 automation-relevant sectors of the German machinery industry were investigated.
3. You get to know the market penetration and market shares for positioning servo. servo drive with technology functions, servo drive with PLC, vector-controlled frequency converters with the asynchronous or the synchronous motor, servo converter at the asynchronous motor, frequency converter (V/f), stepper motor, DC drive, linear drive and torque drive.
